LIST OF PROHIBITED ARTICLES

Passengers and Cabin baggage (hand)

Without contravening the applicable safety rules, passengers are not permitted to carry the following items into security restricted areas and on board an aircraft:

- a) weapons, firearms and other devices that discharge projectiles devices capable, or appearing capable, of being used to cause serious injury by discharging a projectile, including:
 - firearms of all types, such as pistols, revolvers, long heavy rifles, shotguns;
 - toy weapons, replicas and imitations of firearms that can be mistaken for real weapons;
 - component parts of firearms, excluding telescopic sights;
 - compressed air weapons and CO2 weapons, such as pistols, shotguns, ammunition for weapons and long rifles;
 - signaling pistols and pistols for starting sports competitions;
 - bows, crossbows and arrows,
 - harpoon weapons and spear weapons;
 - slingshots and catapults.
- b) stun tools devices specially designed to stun or impede movements, including:
 - shock devices, such as electric stun guns, stun guns and rubber batons;
 - animal stunners and animal killers;
 - chemicals that affect the disabling of the reaction, gases and sprays,
 - such as tear, pain, blinding sprays, pepper spray, tear gas, acid spray and bug spray.
- c) objects with a sharp tip or sharp edge objects with a sharp tip or sharp edge capable of being used to cause serious injuries, including:
 - articles designed to cut, such as axes, battle axes and machetes;
 - ice skates and ice breakers:
 - razor;
 - box opener;
 - knives with blades of more than 6cm;

- scissors with blades more than 6cm measured from the axes;
- martial arts equipment with sharp points or a sharp edge;
- knights' daggers and swords.
- d) work tools tools capable of being used either to cause serious injury or to threaten the safety of aircraft operations, including:
 - levers:
 - drills and drill bits, including portable cordless drills;
 - tools with a blade or a dart of more than 6cm that can be used as a weapon, such as screwdrivers and chisels;
 - saws, including portable cordless saws;
 - welding pipes;
 - door monitoring tool and nail driver.
- e) sharp instruments objects that can be used to cause serious injuries when used to strike, including:
 - baseball bats;
 - golf bats and police bat and billiard cues;
 - martial arts equipment.
- f) explosives and incendiary substances explosive substances and incendiary substances and devices capable, or appearing capable, of causing serious injury or posing a threat to the safety of the aircraft, including:
 - ammunition;
 - blast cap;
 - detonators and fuses;
 - forgeries or imitation of explosive materials;
 - mines, grenades and other explosive military equipment;
 - fireworks and other pyrotechnics;
 - cartridges that create smoke;
 - dynamite, gunpowder and plastic explosives.

Airplane hold baggage

Passengers are not allowed to carry the following items in their hold baggage:

Explosives, devices and combustible substances - explosives and combustible substances in a state and devices capable of being used to cause serious injury or posing a threat to the safety of the operation of the aircraft, including:

- ammunition;
- blasting mold;
- detonators and (fuse) exploded key;
- mines, grenades and other explosive military stores;
- fireworks and other pyrotechnics;
- smokers in boxes and cylindrical containers;
- dynamite, gunpowder and plastic explosives.
